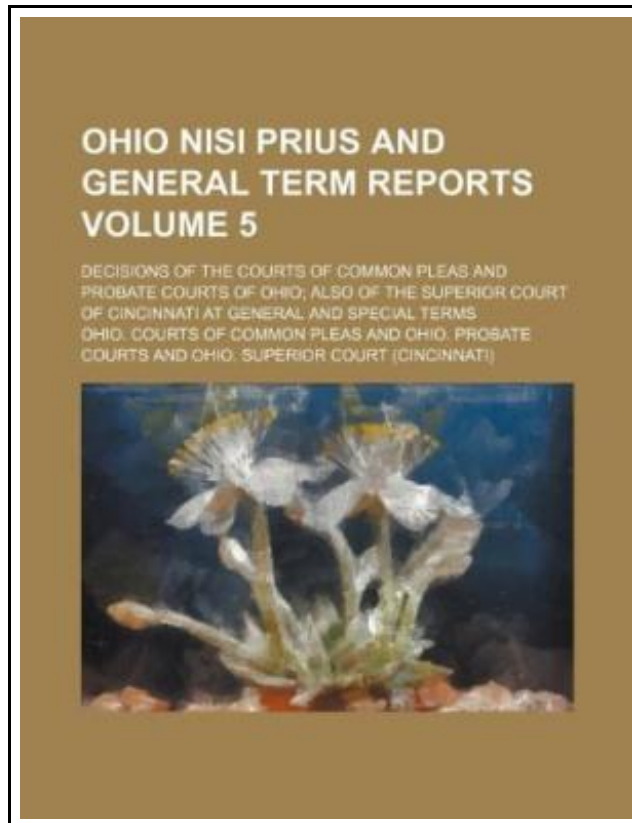

Not illustrated. 1898 Excerpt: .injunction in this case, entitled London Whiffs, is a device purely fanciful and arbitrary, and, in no way, suggestive of the color, ingredients, mode of composition, of the article to which such label is attached, and that, therefore, the label is itself the subject of a trade-mark or exclusive right to a trade-mark. The evidence establishing, then, that the plaintiffs had used this device for the term of two years or more prior to its adoption by the defendant, and it being now apparent that it is the subject of a trade-mark, that is, that it is a subject that the plaintiffs could acquire the exclusive right to use, we are remitted to the next question in order, that is, whether the label adopted by the defendants, and now used by the defendants, is a colorable imitation of the label of plaintiffs.
